SA Contract Ratification Vote Results

We want to thank the membership for your support last night at our Ratification Meetings / Votes held at the Glenmore Inn & Convention Centre.

The results of the June 21, 2016 Ratification Votes are as follows:

- 100% of our Professional Support Staff Members supported the Recommended Terms for Settlement for the PSS Agreement.
- 74% of our Main Body Support Staff Members supported the Recommended Terms for Settlement for the Main Body Agreement.

The Calgary Board of Trustees Ratification Vote takes place next Tuesday, June 28, 2016.

Applying for Employment Insurance (EI)

- A couple of CBE Communications have been e-mailed to employees and this information has been copied and pasted directly from that. The CBE communication is available by logging into CBE's Website (www.cbe.ab.ca) and clicking on the "staff" tab at the top of their homepage (log-in to the staff insite homepage staff insite→locate system tools→news centre→news→(scroll down to: Summer 2016 Mass ROE Communication).
- If you have any questions, please call CBE'S Employee Contact Centre at 1.877.353.2555 or Service Canada directly at 1.800.206.7218.
- To file, please go to www.servicecanada.gc.ca select "Apply for Employment Insurance."
- CBE will automatically have Records of Employment (ROE) issued electronically to Service Canada via the Web for 10-month support staff by July 8, 2016.

Tips for completion of application:

• During the application process you will be asked if you are part of a group layoff, indicate yes and provide the following support staff reference code: 4812012016082016.

Applying for Employment Insurance – Notice for School-Related Employees (pdf)

- Return to work date is a mandatory field. If you have not been provided with a date, indicate Oct. 31, 2016.
- These codes are only effective May 30 August 26, 2016.
- Do not use the above noted reference code if you are applying for Special EI benefits as specified in the attached notice.
