Important Registration Information

Due to extremely high demand on our site Thursday evening, once you have logged in and see the "spinning wheel" you are connecting within our site, so please be patient as it may take a few minutes for you to have the ability to register for sessions. **DO NOT** log-out and then in again as: 1) you will lose your spot in the queue; and 2) logging in and out on the site can cause our system to overload.

This will help the system from getting bogged down when multiple members are searching session offerings that evening.

Article 10 - Attending SA's Convention

Article 10 - Staff Association Convention

10.1 Continuous and term-specific employees will be allowed at least two (2) days, with pay, to attend the annual Staff Association Convention unless operational/work requirements prevent the absence from work of an employee for both days, in which case the employee will be allowed at least one (1) day, with pay, to attend. Employees not required to work either of the days of the Staff Association Convention shall not be entitled to receive additional compensation for time spent at the Staff Association Convention.

Please note: Continuous employees - if you are not at work you are expected to attend Convention. If you are not at Convention, you need to have made alternate arrangements with your immediate supervisor as you are paid for the two days during Convention. This means taking personal days, vacation days, utilizing lieu time or taking the days without pay.

- Continuous employees are not paid extra if time spent in Convention session(s) exceed regular paid work hours.

Time sheeted employees – you are welcome to participate in virtual sessions but are not paid for doing so.
